# Legislative Updates - June 28, 2024

## HB 68 The SAFE Act and Save Women's Sports Act

**Description**: Prohibits puberty blockers, cross-sex hormones, and surgeries for the purpose

of "gender transition" for minors, and protects females in K-12 and collegiate

sports from being forced to compete against males

Status: The ACLU filed a lawsuit on March 26th in an attempt to prevent the law from

going into effect.

Action Steps: Pray against the lawsuit, and that the court would rule in favor of HB 68

# HB 8 The Parents' Bill of Rights

**Description:** Requires public schools to inform parents of teaching on sexual content and

prohibits school staff from encouraging students to withhold information from

their parents

Status: Waiting to be voted out of the Senate Education Committee and sent to the

Senate floor for a vote of the full chamber

Action Steps: Contact the Senate Education Committee members and ask them to support

passage of the bill - ohiosenate.gov/committees/education

# SB 159 Pregnancy Center Tax Credit

**Description:** Establishes a dollar-for-dollar tax credit for donations to certain qualifying

pregnancy resource centers

Status: Waiting for a fourth hearing in the Senate Finance Committee, then it can be

voted out of the committee and sent to the Senate floor for a vote of the full

chamber

Action Steps: Contact the Senate Finance Committee members and ask them to support

passage of the bill - ohiosenate.gov/committees/finance

### **SB 212 Protecting Children from Porn**

**Description:** Protects minors from viewing explicit content online by requiring porn

websites to verify that users are over 18

**Status:** Waiting to be voted out of the Senate Financial Institutions and Technology

Committee and sent to the Senate floor for a vote of the full chamber.

#### **HB 339 Non-chartered Schools ESA**

Description: Creates an Education Savings Account (ESA) for students to attend

non-chartered non-public schools with state dollars

Status: Waiting for a third hearing in the House Primary and Secondary Education

Committee

Action Steps: Contact the House Primary and Secondary Education Committee members and

ask them to support passage of the bill -

# **HB 245 Protecting Children from Obscene Entertainment**

**Description:** Requires obscene adult performances such as drag shows to be restricted to spaces where only people 18 and older are permitted

Status: Waiting for a second hearing in the House Criminal Justice Committee

Action Steps: Contact the House Criminal Justice Committee members and ask them to

support passage of the bill - ohiohouse.gov/committees/criminal-justice

## **HB 183 Single-Sex Bathrooms**

**Description:** Requires schools and colleges (public and private) to designate separate

bathrooms for males and females

**Status:** Amended onto another bill and passed the House! Waiting for the Senate to

concur and then it can go to the governor for his signature

Action Steps: Contact Senate President Matt Huffman and ask him to reconvene the Senate

### **HB 445 Religious Released Time**

**Description:** Changes the law regarding released time for religious instruction from "may" to

"shall" so public school districts will have to honor the efforts of groups like

LifeWise Academy

Status: Waiting for a third hearing in the House Primary and Secondary Education

Committee

**Action Steps:** Contact the House Primary and Secondary Education Committee members

and ask them to support passage of the bill -

# **SB 217 Deepfake Restrictions**

**Description:** Requires AI-generated content to use a watermark, bans the production of

AI-generated child porn, and prohibits identity fraud using someone else's

replica

Status: Waiting for a third hearing in the Senate Judiciary Committee

Action Steps: Contact the Senate Judiciary Committee members and ask them to support

passage of the bill - ohiosenate.gov/committees/judiciary

# **HB 602 Protecting Homeschoolers from Daycare Regulation**

Description: Ensures that homeschool co-ops are not subject to the same regulations as

daycares

Status: Waiting for a third hearing in the House Public Health Policy Committee

Action Steps: Contact the House Public Health Policy Committee members and ask them to
